ORDER:-

In the circumstances reported by the Director of Municipal Administration, Hyderabad and after careful examination of the matter, Government hereby empower the following Officers in addition to the Police Officers not below the rank of a Sub-Inspector to remove, erase or otherwise pull down any objectionable Advertisement, in exercise of the powers conferred by sub-section (1) of section 6 of The Telangana Prevention of Disfigurement of Open Places and Prohibition of Obscene and Objectionable and Advertisements Act, 1997 (Act 28 of 1997):


