**ORDER:**

In the reference 1<sup>st</sup> read above Government have issued certain guidelines for installation of Ground Based, Rooftop tower shelters and antennas etc.

2. Subsequently, Government vide reference 2<sup>nd</sup> read above, have issued an amendment to the Government Order 1<sup>st</sup> read above basing on the directions of Hon'ble High Court of Andhra Pradesh. Further, Government vide reference 3<sup>rd</sup> read above have clarified certain concerns / apprehensions / doubts raised on insisting of NOC from owner of the Building on which Cell Phone Towers are proposed to be erected.

3 In the reference 4<sup>th</sup> read above, comprehensive guidelines were issued for clearances of installation of new Telecommunication Infrastructure Towers.

4. A representation has been received vide reference 5<sup>th</sup> read above from M/s TAIPA & M/s Reliance Jio for amendment to Comprehensive Guidelines taking in to consideration the difficulties faced by the Telecom Infrastructure providers while rolling out new services for mobiles in the Telangana State .

5. In the reference 5<sup>th</sup> above, the IT&C Department has proposed certain Amendment to G.O.Ms.No.380 MA, Dated: 01.08.2013, in order to make Hyderabad as 4G enable city and directed ITE&C department to expedite clearances by removing all hurdles for rapid rollout of 4G and for growth of Mobile Telecom Industry in the State.

6. Government after careful examination of the matter hereby issue the following amendments to the comprehensive guidelines issued in the Government Order 4<sup>th</sup> read above.

**AMENDMENT**

In the rule (F) (ix) of G.O.Ms.No.380, MA Dated: 01.08.2013, for the words:

*“Erection of any telecommunication Infrastructure tower or pole structures or accessory rooms shall be permitted only on buildings with valid permissions and Occupancy Certificate obtained from the Local Body” shall be deleted”.*

the words:

**“Permitting the Mobile Towers basing on the NOC from the building owners instead of Sanctioned plan / Occupancy certificate.”** shall be substituted.

7. All the other guidelines / conditions mentioned in the Government Order 4<sup>th</sup> read above holds good.

8. All the Commissioners of Municipal Corporations, Municipalities and Nagara Panchayats, the Metropolitan Commissioner, Hyderabad Metropolitan Development Authority, Hyderabad and Vice-Chairmen of Kakatiya Urban Development Authority, Executive Officers of Gram Panchayats Urban Development Authorities shall take necessary further action accordingly.
