Whereas, in the G.O 1<sup>st</sup> read above, Andhra Pradesh Municipalities (Conduct of Election of Chairperson and Vice-Chairperson) Rules, 2005 were issued;

2. And whereas, in the G.O 2<sup>nd</sup> read above, Andhra Pradesh Municipalities (Conduct of Election of Chairperson and Vice-Chairperson) Rules, 2005 have been adapted to the State of Telangana;

3. And whereas, in the circumstances reported by the Secretary, Telangana State Election Commission, Hyderabad in the letter 3<sup>rd</sup> read above, it has been decided to amend the Telangana Municipalities (Conduct of Election of Chairperson and Vice-Chairperson) Rules, 2005, suitably.

4. Accordingly, the following Notification will be published in an Extraordinary Issue of the Telangana Gazette, dated: 24.07.2017.

NOTIFICATION

In exercise of the powers conferred by section 326 of the Telangana Municipalities Act, 1965, the Governor of Telangana hereby makes the following amendments to the Telangana Municipalities (Conduct of Election of Chairperson and Vice-Chairperson) Rules, 2005, as amended from time to time.

AMENDMENTS

In the said rules, in Form -II after the words "at its office for the election of Chairperson and Vice-Chairperson" the following words shall be inserted namely,-

"If for any reason such an election is not held on that day, it will be held on the next day whether or not it is a holiday observed by the Municipality"
