**NOTIFICATION**

In exercise of the powers conferred by clause (42-a) of section 2 of the Telangana Municipalities Act, 1965 (Act No. 6 of 1965), read with rule 2 of the Andhra Pradesh Transitional Area and Smaller Urban Areas (Fixation of Criteria) Rules, 2013 issued in G.O.Ms.No.16, MA&UD (Elec.I) Department, dated the 16.01.2013, the Governor of Telangana hereby specifies the areas covered under the erstwhile Boduppal and Chengicherlla Grampanchayats of Rangareddy District as Boduppal Smaller Urban Area (Municipality) with immediate effect and thus Boduppal Municipality is deemed to have been constituted under sub-section (1) of section 3 of the Telangana Municipalities Act, 1965.
